The Prom is a school-sponsored activity. School and district policies will be fully enforced, especially those related to drugs and alcohol. Security officers and school personnel will be observing and/or checking students at the door and throughout the evening. Anyone found to be under the influence or in the possession of drugs or alcohol will be referred to the local police as required by state law. Suspension from school is automatic. Prom ticket money will not be refunded.

Dear Parents,

The 2017 Junior/Senior Prom will be held at the Abigail Gardens @ the Abernethy Center, 606 15th Street, Oregon City, Oregon, 97045 from 8:00 p.m. to 11:00 p.m. on Saturday, April 15, 2017. A map with directions to the site will be available to students at the time of ticket purchase. The Junior class and advisors have worked hard to plan a memorable evening for all students attending.

In order to ensure the Prom is a fun and safe student activity, all school and district policies prohibiting the possession, use, sale or influence of drugs and alcohol will be strictly enforced. Another issue that has potential to lead to problems is the style of dancing that is becoming popular. School policy prohibits dancing that is sexually suggestive (freaking) or dangerous (moshing or break dancing). Supervisory personnel will be alerted to students who violate these policies and the students will be required to leave the dance. At the bottom of this letter is the contract each student planning to attend has been asked to read and sign.

You can help us make this activity safe for all students. Please discuss this permission slip with your son or daughter, and reinforce the importance of abiding by these school policies before signing step one of the dance pass application on the reverse side of this letter. DANCE CONTRACT

1. All students and guests attending the dance must have an approved dance pass on file with Mrs. Anderson by the deadline.
2. All students and guests must abide by the dress code i.e. the dance is semi-formal.
3. A Camas High School student ID card will be **required** for entrance to the dance.
4. Students wishing to bring a guest must submit a completed dance pass by the deadline. The guest will also be held accountable to the Camas High School dance contract rules, must have picture ID, and must be at least 9th grade and no older than 20 years of age. In the case that the guest behaves inappropriately, the CHS student will be held accountable for his/her guest's actions.
5. Once you leave the dance, you will not be permitted to re-enter.
6. **Inappropriate dancers will be asked to leave and parents will be contacted.**
7. There will be a **NO TOLERANCE** policy for drug/alcohol use prior to or at the dance.
8. If removed from the dance there will be **NO REFUND**.
9. Administrators reserve the right to shut down the dance due to inappropriate dance behavior.
